Alumni Association Dues

- Fundraising/Charity:

 - Both events have raised a total of \$7,500 this school year which will result in approximately **\$5,000 donated to charities this school year by the chapter**
 - Spring Golf Tournament: Although the tournament was a resounding success (\$6,000 in revenue) there was limit alumni participation, so we would like to solicit suggestions on how to improve the tournament so that it's more convenient for alumni to participate.  - Decided to initiate discussion based on new University loan program aimed at providing loans to student organizations for housing improvements
 - Exploring the sale of the 10th Ave house to increase chapter's cash savings and pay off Fitts Architecture
